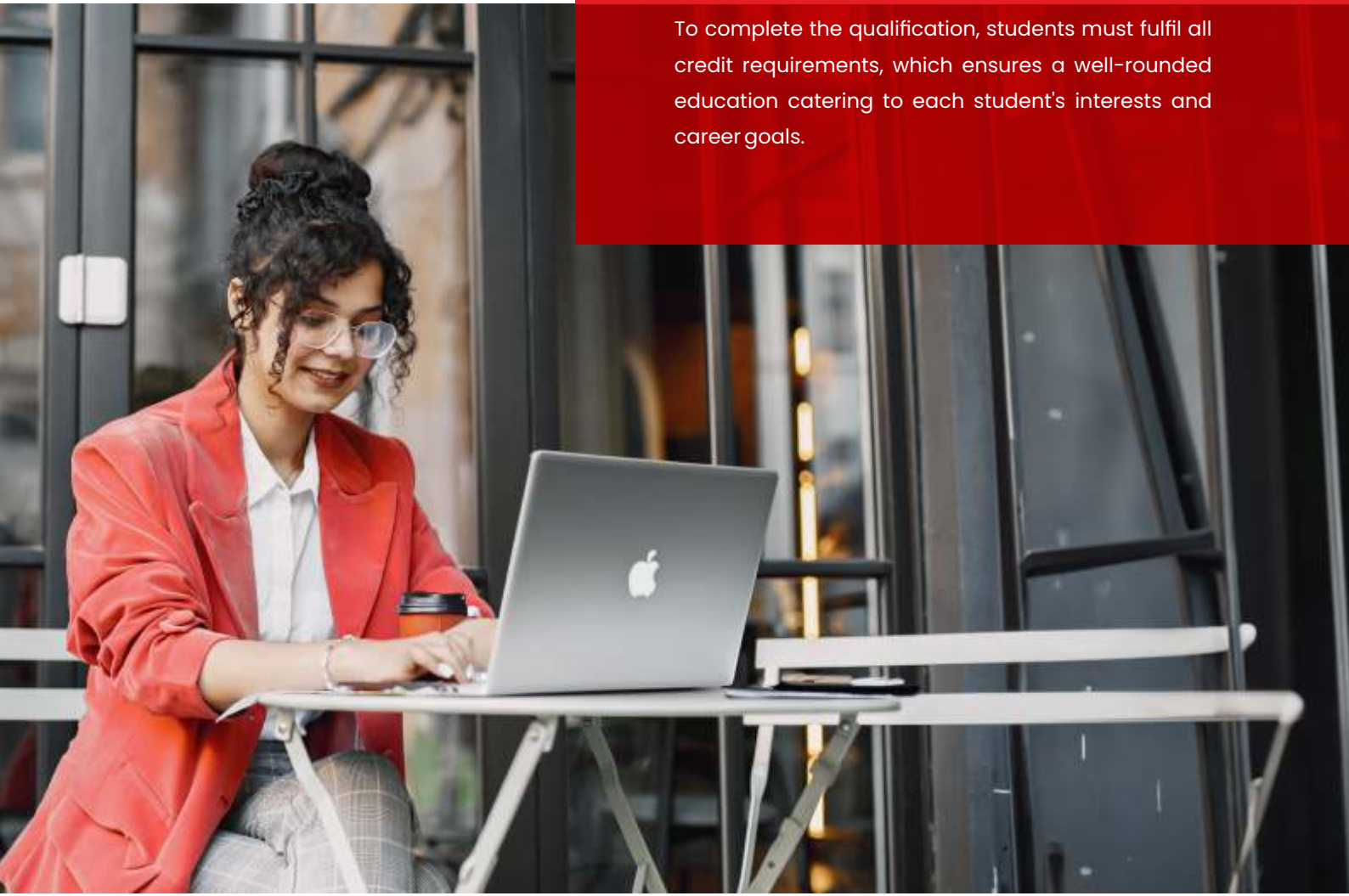




Programme Outcome

The B.Sc International Finance is a prestigious qualification aimed at enhancing individuals' skills and knowledge in accounting.

To complete the qualification, students must fulfil all credit requirements, which ensures a well-rounded education catering to each student's interests and career goals.

To pass an undergraduate module, a student must obtain at least 40% overall, and at least 30% in each equivalent ACCA paper.

Programme Duration

The duration of the programme is 9 Months.

Mode of Study

Face to Face Taught / Blended.

The programme is delivered by ISDC Learning; validated and awarded by QMU.

Classes for each module will be delivered through a combination of in person classes, Pre-recorded videos and Live online sessions.

Students should expect between 20-30 hours primary contact time per module, over the course of a semester. Primary contact hours should be understood to be 'synchronous time tabled activities. These may be delivered in person, or during a 'live' online class. A minimum of 4 hours of primary contact time will be delivered face-to-face per week by ISDC staffs at ISDC campuses in Bangalore/ Kochi.

In addition to this; students will have the access to the ISDC Pro – an ACCA approved digital content for pursuing the ACCA Qualification.

Programme Cost

The fees for ISDC's ACCA Professional Qualification Pathway is **£ 1,500** (Includes exclusive access to P-Level ACCA Papers).

The fee covers registration of the learner to the qualification, access to ISDC digital content, one time assessment of all the modules and certification.

Learners must pay the additional fees of £30 per assessment if in case of exam retake/resit.

Students may have to pay the Professional Level Examination Fees and the Relevant Annual Subscription Fees on top of the Programme Cost mentioned above to ACCA.

- Proficiency in English



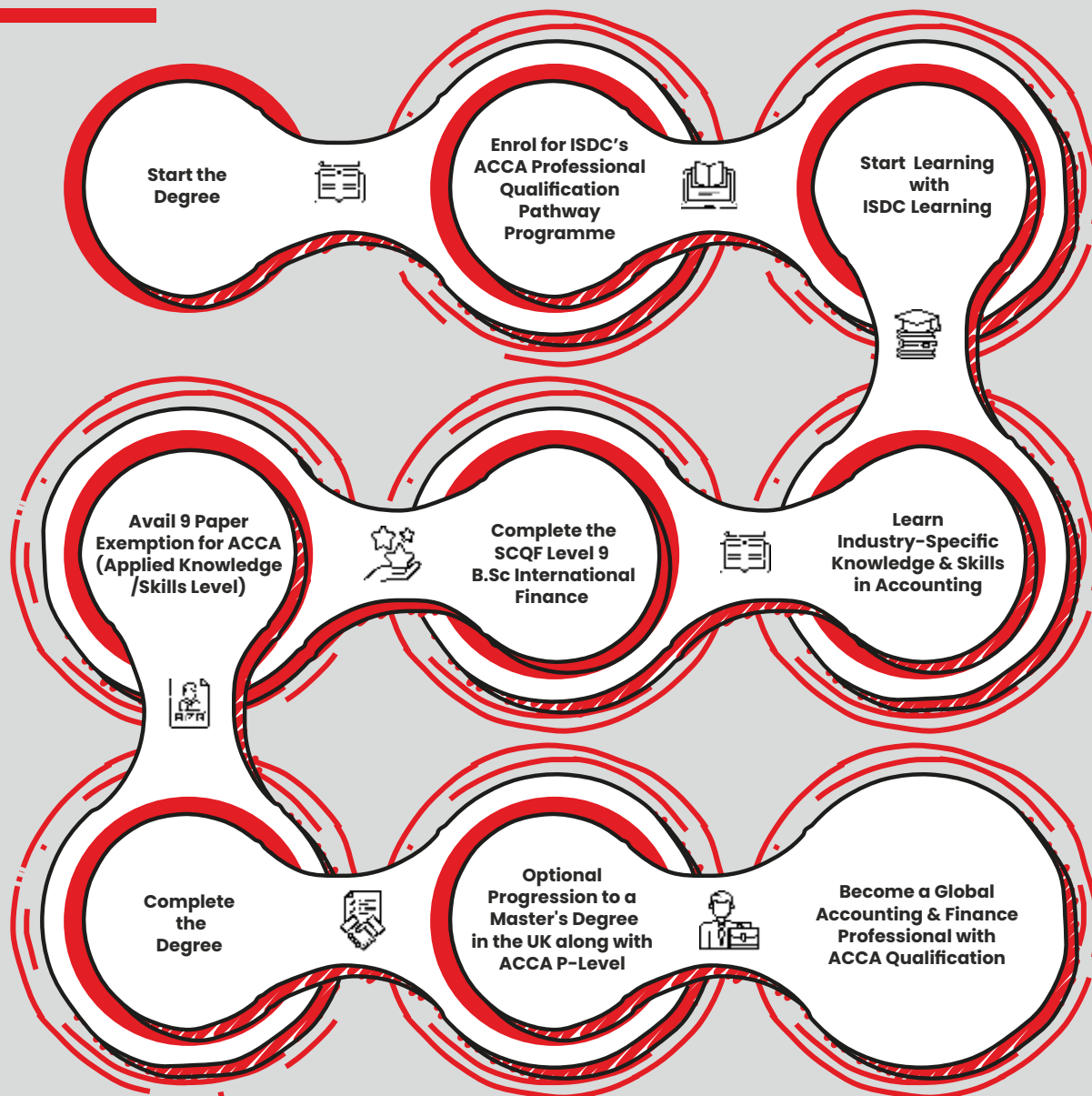


